Focus on S/4HANA data migrations and data-driven quality assurance—from structured legacy extraction through staging/transformation and cutover planning to post-load validation, re-runs and stabilizing hypercare. I combine hands-on delivery experience with an audit and controls mindset: I design and test IT general controls as well as application controls in the context of migrations and interfaces in line with ISAE 3000/3402 and IDW PS 880 (including traceable documentation, runbooks and defensible evidence). Operationally, I work hands-on with SAP Migration Cockpit, HANA SQL/SQL Script, SAP Data Services, Python (pandas) and Alteryx, automate template population, checks and logging, and perform reconciliations across master data, transactional data and open items across systems. I translate results into management-ready insights: I regularly visualize KPI-based progress and quality metrics, variance analyses and reconciliation statements in Power BI for stakeholders up to C-suite level—complete with clear root-cause narratives and actionable corrective measures. I also bring experience in heterogeneous system landscapes (e.g., non-SAP sources, ERP/EMR integrations) and across multiple industries.
